Category	Question	Answer
General	What is this campaign about?	<p>The GX Card Rewards Campaign (“Campaign”) is organised by GX Bank Berhad and will run from 6 November 2024 to 6 May 2025 (“Campaign Period”), or such other dates as may be determined by GXBank from time to time with prior notice to you.</p> <p>There are three (3) reward categories available:</p> <ol style="list-style-type: none"> 1. Retail and Online Spend Using Physical and Virtual GX Card (“Reward Category 1”); 2. Overseas Retail Spend Using Physical GX Card (“Reward Category 2”); and 3. Jaya Grocer In-Store Spend Using Physical GX Card (“Reward Category 3”).
	Am I eligible to participate in this campaign?	<p>The Campaign is open to all individual customers of GXBank with a savings account with GXBank (“GX Account”).</p> <p>The following individuals are <u>not eligible</u> to participate in the Campaign:</p> <ol style="list-style-type: none"> (a) customers whose GX Account or GX debit card (“GX Card”) has been terminated, closed, suspended, deemed delinquent or otherwise unsatisfactorily conducted as determined by GXBank during the Campaign Period; (b) individuals who are mentally unsound, deceased, adjudicated bankrupt or have any legal proceedings instituted against them; and/or (c) individuals under the age of eighteen (18) years.

	What is the Reward?	<p>You will receive 0.10% cashback for eligible retail and online spend using your GX Card (virtual or physical) during the Campaign Period.</p> <p>Please note that overseas retail purchases made with the physical GX Card are not included as Eligible Spend</p>
	How do I participate to earn this Reward?	<p>It’s simple! Just perform retail and online transactions using your GX Card (virtual or physical) and you will get 0.10% cashback on your Eligible Spends.</p>

		<p>Eligible Spend using the GX Card shall NOT include certain transactions (i.e. “Excluded Transactions”) as outlined in Clause 3.3 of the GX Card Rewards Campaign Terms and Conditions and no cashback reward shall be granted in respect of such transactions.</p>
	<p>When and how will I receive this Reward?</p>	<p>The cashback value will be calculated and rounded down to the <u>nearest two decimal points</u>. Cashback amount must be <u>at least RM0.01</u> in order to be credited to your GX Account.</p> <p>If an Eligible Customer spends between RM 1 to RM 10, the minimum cashback they will earn per transaction is RM 0.01.</p> <p>The cashback will be credited to an Eligible Customer’s GX Account after the Eligible Spend is either authorised or settled, i.e., when the Eligible Spend is under the “Processing” or ”Successful” status. In exceptional cases, crediting of the cashback could take up to two (2) weeks from the date the Eligible Spend is performed. If the Eligible Spend is subsequently cancelled, any credited cashback amount will be clawed back or debited from the Eligible Customer’s GX Account.</p>
<p>Reward Category 2</p>	<p>Overseas Retail Spend Using Physical GX Card</p>	
	<p>What is the Reward?</p>	<p>You will receive 1% cashback for eligible retail spend using your physical GX Card overseas during the Campaign Period.</p>
	<p>How do I participate to earn this Reward?</p>	<p>It’s simple! Just perform retail transactions overseas using your physical GX Card and you will get 1% cashback on your Eligible Overseas Spends.</p> <p>Eligible Overseas Spend using the GX Card shall NOT include certain transactions (i.e. “Excluded Transactions”) as outlined in Clause 3.3 of the GX Card Rewards Campaign Terms and Conditions and no cashback reward shall be granted in respect of such transactions.</p>
	<p>When and how will I receive this Reward?</p>	<p>The cashback value will be calculated and rounded down to the <u>nearest two decimal points</u>. Cashback amount must be <u>at least RM0.01</u> in order to be credited to your GX Account.</p> <p>The cashback will be credited to an Eligible Customer’s GX Account after the Eligible Overseas Spend is either authorised or settled, i.e., when the Eligible Overseas Spend is under the “Processing” or ”Successful” status. In exceptional cases, crediting of the cashback could take up to two (2) weeks from the date the Eligible Overseas Spend is performed. If the Eligible Overseas Spend is subsequently cancelled, any credited cashback amount will be clawed back or debited from the Eligible Customer’s GX Account.</p>

Reward Category 3	Jaya Grocer In-Store Spend Using Physical GX Card	
	What is the Reward?	You will receive 1.5x GrabRewards points for every RM1 spent using your physical GX Card at Jaya Grocer's physical stores.
	How do I participate to earn this Reward?	<p>To be an eligible customer for this reward campaign, you must:</p> <ol style="list-style-type: none"> 1. Have an active physical GX Card; and 2. Have an active Jaya Grocer membership. <p>To receive this Reward, you must perform the below during checkout at any Jaya Grocer retail store nationwide:</p> <ol style="list-style-type: none"> 1. Scan your Jaya Grocer membership barcode (available in your Grab App); and 2. Pay for your purchase using your physical GX Card. <p><i>*Note that this Reward is <u>not applicable to online orders performed via the GrabMart or Jaya Grocer Online.</u></i></p>
	When and how will I receive this Reward?	GrabRewards points will be credited to your Grab account on the Grab App instantly once your transaction has been successfully completed. In exceptional cases, crediting of the GrabRewards points could take up to two (2) weeks from the date of your successful transaction.
