

## Frequently Asked Questions: GXBANK QR Cashback Campaign

<p>What is this campaign about?</p>	<p>This <b>GXBANK QR Cashback Campaign</b> ("Campaign") is organised by GX Bank Berhad ("<b>GXBANK</b>") in collaboration with Payments Network Malaysia Sdn Bhd ("<b>PayNet</b>") and will run from <b>6 May 2025 to 14 September 2025</b> (both dates inclusive) or upon reaching the <b>Maximum Cap</b>, whichever is earlier, or as otherwise determined by GXBANK with prior notice ("<b>Campaign Period</b>").</p> <p><u>Important Note:</u> This Campaign has a maximum limit of RM650,000 throughout Campaign Period ("<b>Maximum Cap</b>"). <p>Am I eligible to participate in this campaign?</p>	<p><b>Campaign Eligibility:</b> This Campaign is open to all individual customers of GXBANK with a GX Account in good standing and make payment using GX App via the merchant static or dynamic DuitNow QR code ("<b>Eligible Customer</b>").</p>										
<p>What is the campaign reward and how can I earn it?</p>	<p><b>Campaign Reward:</b> <b>0.2% Cashback on Eligible transaction made via in-store merchant static or dynamic DuitNow QR code</b></p> <p><b>Qualifying Criteria:</b> To receive the Campaign Reward, you must:</p> <ol style="list-style-type: none"> <li>1. have an existing GX Account in good standing; and</li> <li>2. make DuitNow QR payment(s), with a minimum transaction amount of RM5, using the GXBANK mobile application ("<b>GX App</b>") by scanning a merchant's DuitNow QR code (static or dynamic) during the Campaign Month Period as listed in Table A ("<b>Eligible Transaction</b>").</li> </ol> <p><b>Campaign Reward Eligibility:</b></p> <ol style="list-style-type: none"> <li>(a) <b>Minimum Transaction Amount:</b> Each transaction must be at least RM5 to qualify as an Eligible Transaction ("<b>Minimum Transaction Requirement</b>").</li> <li>(b) <b>Monthly Cashback Cap:</b> Cashback is capped at RM5 per Eligible Customer, per Campaign Month ("<b>Monthly Cap</b>").</li> <li>(c) <b>Campaign Period Cap:</b> A maximum of RM20 cashback may be earned by each Eligible Customer over the entire Campaign Period.</li> <li>(d) <b>Calculation and Rounding:</b> Cashback amounts will be calculated at 0.2% of the Eligible Transaction amount and rounded down to two (2) decimal places.</li> </ol>

Campaign Month 2	<p>Performed the following three (3) DuitNow QR payments totaling RM500 using the GX App to scan merchant DuitNow QR codes:</p> <ul style="list-style-type: none"> <li>• RM2</li> <li>• RM400</li> <li>• RM98</li> </ul> <p>Note: The first transaction (RM2) does not meet the RM5 minimum requirement, and is therefore <i>not eligible</i> for cashback. The second (RM400) and third (RM98) transactions meet the RM5 minimum requirement and are eligible for cashback. (refer to <b>Campaign Reward Eligibility</b>)</p>	<p><u>Cashback Calculation</u>            RM400 × 0.2% = RM0.80            RM98 × 0.2% = RM0.19</p> <p><b>Total cashback earned = RM0.99</b></p> <p><i>Note: Cashback will be credited by the end of the following day after the Eligible Transaction date</i></p>
Campaign Month 3	<ul style="list-style-type: none"> <li>• Performed one (1) DuitNow QR payment worth RM1,500 using the GX App to scan a merchant DuitNow QR code</li> </ul> <p>Note: Transaction meets the RM5 minimum requirement (refer to <b>Campaign Reward Eligibility</b>)</p>	<p><u>Cashback Calculation</u>            RM1,500 × 0.2% = RM3.00</p> <p><b>Total cashback earned = RM3</b></p> <p><i>Note: Cashback will be credited by the end of the following day after the Eligible Transaction date</i></p>

Campaign Month 1	<p>Performed one (1) DuitNow QR payments totaling RM1,500 using the GX App to scan merchant QR codes</p> <p>Note: Transaction meets the RM5 minimum requirement (refer to <b>Campaign Rewards Eligibility</b>)</p>	<p><u>Cashback Calculation</u>  <math>RM1,500 \times 0.2\% = RM3</math></p> <p><b>Total cashback earned = RM3</b></p> <p><i>Note: Cashback will be credited by the end of the following day after the Eligible Transaction date</i></p>
Campaign Month 2	<p>Performed the following two (2) DuitNow QR payments totalling RM3,000 using the GX App to scan merchant DuitNow QR codes:</p> <ul style="list-style-type: none"> <li>• RM2,800</li> <li>• RM200</li> </ul> <p>Note: Both transactions meet the RM5 minimum requirement (refer to <b>Campaign Rewards Eligibility</b>)</p>	<p><u>Cashback Calculation</u>  <math>RM2,800 \times 0.2\% = RM5.60</math>  <math>RM200 \times 0.2\% = RM0.40</math></p> <p><b>Total cashback earned = RM5</b></p> <p>Due to the Monthly Cap, Customer B will only be entitled to receive <b>RM5 cashback</b> for Campaign Month 2 (refer to <b>Campaign Rewards Eligibility</b>)</p> <p><i>Note: Cashback will be credited by the end of the following day after the Eligible Transaction date</i></p>
Campaign Month 3	Spent RM1,500 using the GX Debit Card (not via DuitNow QR)	Not eligible for cashback as payment was not made by scanning merchant DuitNow QR code via GX App.

<p>When will I receive the campaign reward?</p>	<ul style="list-style-type: none"> <li>• This Campaign Reward will be <b>credited to the Eligible Customer's GX Account by the end of the following day</b>, after the Eligible Customer has successfully completed the Qualifying Criteria</li> </ul> <p><i>Note: In exceptional cases, crediting of the Campaign Reward could take up to two (2) weeks after completion of the Qualifying Criteria.</i></p> <ul style="list-style-type: none"> <li>• If an Eligible Transaction is cancelled, voided, refunded, or otherwise deemed invalid, the corresponding cashback will be reversed and debited from the Eligible Customer's GX Account, regardless of whether the cashback has already been credited</li> </ul>
